By the signature of its authorized representative below, Applicant, on behalf of itself and its Affiliates (as defined in the Bylaws), agrees to be bound by the terms hereof, as well as the terms and conditions stated in the Articles of Incorporation, Bylaws, Antitrust Guidelines and IPR Policy (“Organizational Documents”) of RVU Alliance as may apply to the Promoter membership classification stated in the Bylaws. Copies of the RVU Alliance Organizational Documents are available for review at the administrative offices of RVU Alliance located at RVU Alliance Administration, 3855 SW 153rd Drive, Beaverton, OR 97006. Applicant is encouraged to review these materials prior to the execution of this Membership Agreement.

No Membership Agreement is binding on RVU Alliance unless accompanied by the initial membership fee as noted above (which fee may be deferred by action of the Board of Directors of RVU Alliance for up to thirty (30) days from execution hereof). Membership in RVU Alliance is open to any entity supportive of RVU Alliance’s Purpose as stated in the Bylaws, which has executed the Bylaws and applicable Membership Agreement, and paid the appropriate fee. By signing below, the individual executing this Agreement on behalf of Applicant represents that he or she has all requisite signing authority for and on behalf of the entity seeking membership.

The term of membership shall be on a year-to-year basis, expiring at the end of the 365th day from the date of execution of this Membership Agreement. RVU Alliance will invoice the then-current renewal fee to Members ninety (90) days prior to the expiration of the pending term and a Member’s payment thereof shall constitute a renewal of membership as a Member. Failure to make a timely renewal payment may cause suspension and termination of membership and member benefits.

The undersigned agrees that once received by RVU Alliance, all membership fees are nonrefundable for any reason, including termination of membership. There is no duty to renew any membership and renewal may only be accomplished as set forth above.

Any claim or dispute arising under or relating to this Membership Agreement shall be governed by the internal substantive laws of the State of Oregon, without regard to principles of conflict of laws.
